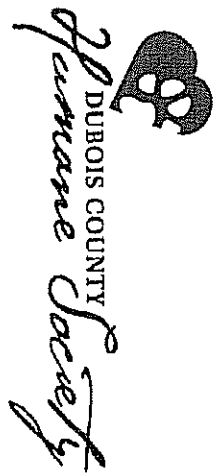

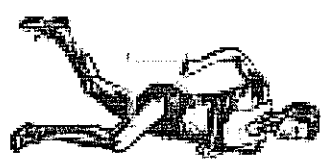
### MUST BE COMPLETED FOR ENTRY TO BE ACCEPTED.

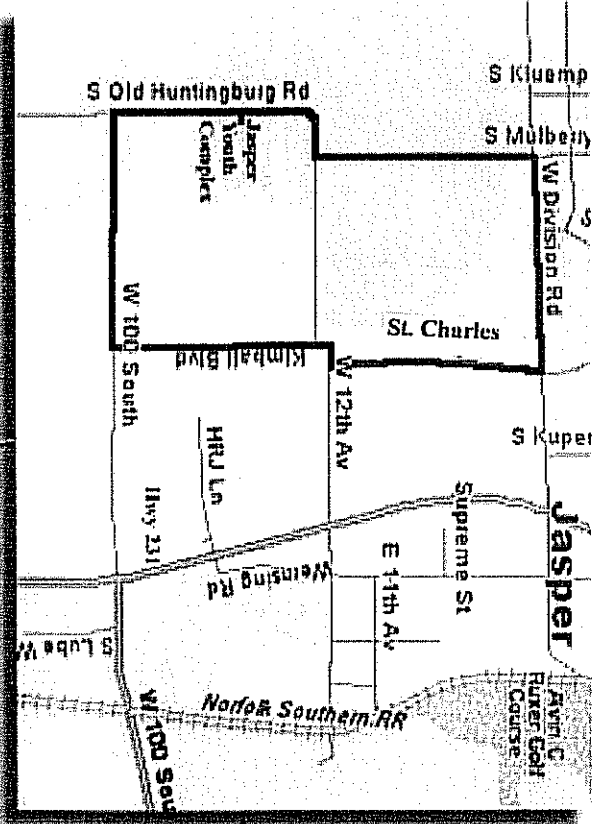

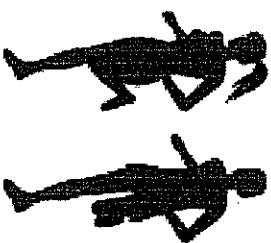
